Executive Summary^a

- 1. The purpose of this document is to provide a report for information on the program for the development of information materials.
- 2. In particular the document reports that:
- (a) new drafts of explanatory notes concerning propagation and propagating material, harvested material, essentially derived varieties, cancellation, nullity, variety denominations and provisional protection were circulated in May 2014, and comments were received by CAJ members and observers; on the basis of comments received, new drafts of the above explanatory notes will be posted by August 29, 2014, which will be considered by the CAJ-AG, at its ninth session to be held on October 14 and 17, 2014; a report on the work of the CAJ-AG, at its ninth session, will be presented to the CAJ, at its seventy-first session, to be held in March 2015; and
- (b) the Spanish, French and German versions of the proceedings of the "Seminar on essentially derived varieties", (UPOV Publication No. 358) held in Geneva on October 22, 2013, have now been posted on the UPOV website (http://www.upov.int/meetings/en/details.jsp?meeting_id=29782).
- 3. The document further reports that developments concerning the following matters are not considered in this document, but in documents CAJ/70/3 and CAJ/70/5, respectively:
- (a) developments concerning the revision of document UPOV/INF/5 "UPOV Model Plant Breeders' Rights Gazette" (see document CAJ/70/3); and
- (b) developments concerning the revision of document UPOV/INF/15 "Guidance for Members of UPOV on Ongoing Obligations and Related Notifications and on the Provision of Information to Facilitate Cooperation" (see document CAJ/70/5).

BACKGROUND

- 4. The CAJ¹ agreed an approach for the preparation of information materials concerning the UPOV Convention². It also agreed to the establishment of an advisory group to the CAJ (CAJ-AG) to assist in the preparation of documents concerning such materials³.
- 5. The agreed approach is summarized as follows: the Office of the Union will develop certain draft materials which it considers covers aspects of a straightforward nature and will circulate these to the CAJ for comments within a specified time. In other cases, where it is considered that there are difficult issues, where discussions at a CAJ session would be important for the development of suitable information materials, and also in cases where the drafts on seemingly straightforward materials provoke unexpected concerns when circulated for comments, it was agreed that the assistance of the CAJ-AG would be sought prior to the CAJ being invited to discuss those matters at its sessions.

OVERVIEW OF THE DEVELOPMENT OF INFORMATION MATERIALS

6. An overview of the development of the information materials is provided in the Annex to this document.

MATTERS TO BE CONSIDERED BY THE CAJ-AG AT ITS NINTH SESSION
