LISTS OF VARIETIES UNDER TEST (Item 7 of the Draft Agenda)

Document prepared by the Office of the Union

1. During its seventeenth session, the Technical Committee agreed that lists of varieties under test would be exchanged between the Offices of the member States themselves. To avoid any delays it was further agreed that this exchange would start immediately, even before agreement was reached on the contents of the list, and that proposals for improvement would be reported back to the Committee (see document TC/XVII/5, paragraph 43).

2. So far lists of varieties under test of ten member States have been exchanged (Belgium, Denmark, France, Germany (Federal Republic of), Ireland, Netherlands, New Zealand, South Africa, Spain, United Kingdom).

3. The Technical Working Parties that have met up to the time of writing this document have noted the exchanges of lists of varieties under test and made the following major proposals for improvement:

4. The Technical Working Party for Vegetables recommends to the Technical Committee that it should in future entrust the tasks of distributing these lists to the Office of UPOV (see document TWV/XV/7, paragraph 5).

5. The Technical Working Party for Agricultural Crops endorses the view that the exchange of these lists is only of any value if they reach the persons actually doing the testing and if they are distributed early enough to be available during the growing season, so that, in the event of a problem with a candidate variety, the experts can check and find out what other country is testing the same candidate variety (see document TWA/XI/14, paragraph 29).

6. The other Technical Working Parties have not yet met. Any comments or proposals made by them will form an addendum to this document or will be reported upon orally.

7. To facilitate discussions on the harmonization of contents of the lists, the Annex to this document reproduces the wishes expressed in respect of those contents by the individual Technical Working Parties, and also summarizes the contents of the lists actually exchanged.

8. The Technical Committee is invited:

(i) to note and decide on the proposals made by the Technical Working Parties,

(ii) to discuss the possibilities of further improvement, especially lists with respect to harmonization of the contents of the lists mentioned.
