Technical Working Party on Automation and Computer Programs (TWC)

A tool to define reference collection

- 3. The TWC, at its thirty-fourth session, held in Shanghai, China, from June 7 to 10, 2016, received a presentation by an expert from France on "A tool to define reference collection", a copy of which is reproduced in the Annex to document TWC/34/28, including a demonstration of the prototype software (see document TWC/34/32 "Report", paragraphs 90 and 91).
- 4. The TWC noted the series of functions performed by the software automating searches from a theoretical collection of all varieties of common knowledge to the identification of most similar varieties for comparison in growing trials. The TWC noted that development of the software was expected to be completed in 2017.
