**REPORT**

*adopted by the Council*

Opening of the session

\*1. The Council of the International Union for the Protection of New Varieties of Plants (UPOV) held its forty-fifth ordinary session in Geneva on October 20, 2011, chaired by Mr. Choi Keun-Jin (Republic of Korea), President of the Council.

\*2. The list of participants is reproduced in Annex I to this report.

\*3. The session was opened by the President who welcomed the participants to the Council session marking the fiftieth anniversary of the adoption of the UPOV Convention, in Paris in 1961.

4. The President informed the Council that Peru had deposited its instrument of accession to the 1991 Act of the UPOV Convention on July 8, 2011, and had become the seventieth member of the Union on August 8, 2011. The intervention made by the Delegation of Peru is reproduced in Annex II to this report.

\*5. The Council took the decisions recorded below under each relevant agenda item.

\*6. The draft detailed report on the session will be submitted to the Council for adoption by correspondence.

Adoption of the agenda

\*7. The Council adopted the draft agenda, as proposed in document C/45/1, after the deletion of item 3 and the addition of document C/45/4 Rev. under item 6, document C/45/14 Add. under item 8, and document C/44/7 Rev. under item 15.

Report by the President on the work of the eighty-second session of the Consultative Committee; adoption of recommendations, if any, prepared by that Committee

\*8. The President reported that the Consultative Committee held its eighty-second session in Geneva on October 19, 2011 and on the morning of October 20, 2011. At that session, the Consultative Committee:

- (a) received a demonstration of the redesigned UPOV website and noted the plans for the website to be launched at 12:00 noon on November 1, 2011;
- (b) discussed on an “Assistance” webpage on the UPOV website;
- (c) discussed on a policy for financing speakers and participants at UPOV events;
- (d) noted the plans for the launch of the web-based version of the Plant Variety Database on November 1, 2011;
- (e) approved the recommendations of the Working Group on Rules concerning Observers and requested the Office of the Union to prepare a draft revision of the “Rules Governing the Granting of Observer Status to States, Intergovernmental Organizations and International Non-Governmental Organizations in UPOV Bodies and Access to UPOV Documents” for consideration at its next session; and
- (f) extended the observer status of Asia and Pacific Seed Association (APSA) to the Administrative and Legal Committee (CAJ), the Technical Committee (TC) and the Technical Working Parties (TWPs).

\*9. On the basis of the recommendations of the Consultative Committee, the Council:

- (a) approved the promotion of the Vice Secretary-General to the Assistant Secretary General (ASG) grade of the United Nations common system, starting from January 1, 2012;
- (b) agreed to the adoption of the International Public Sector Accounting Standards (IPSAS) beginning with the financial period starting in 2012; and
- (c) agreed that documents currently in the first restricted area of the UPOV website be made publicly accessible, by removal of the password requirement. It also agreed that, if possible, the removal of the password be arranged to coincide with the launching of the redesigned UPOV website on November 1, 2011.

10. The President recalled that, at the twenty-eighth extraordinary session of the Council, held in Geneva, on April 8, 2011, he had reported that the Consultative Committee had noted the request of the Association for Plant Breeding for the Benefit of Society (APBREBES) of April 5, 2011, to attend meetings of the Working Group on Rules Concerning Observers. He reported that the Consultative Committee had recalled that APBREBES would have the opportunity to present its views at the forty-fifth ordinary session of the Council on October 20, 2011 (see document C(Extr.)/28/4 "Report", paragraph 10).

11. The representative of APBREBES expressed its appreciation for the opportunity to share with the Council APBREBES' views on rules for observers and access to documents. He considered that the review process of the observers' rules illustrated the shortcomings of the current rules and the need for a revision. He reported that APBREBES had made several contributions on that topic: APBREBES had prepared a "Comparative Analysis across Selected International Organizations" and had made a contribution for the work of the Working Group on Rules Concerning Observers (Working Group) at its second meeting on October 17, 2011. He explained that APBREBES would be interested to know what delegates thought about APBREBES' analysis and proposals but he did not have any information about those discussions. He noted that APBREBES had not been granted observer status in the Working Group and that the report of the Working Group, documents, reports and discussions of the Consultative Committee were secret. He noted that the Consultative Committee, at its eighty-second session, had approved the recommendations of the Working Group and as he did not have access to those recommendations he could not comment them. He reported that APBREBES' member organizations had experience from other intergovernmental organizations, such as the Food and Agriculture Organization of the United Nations (FAO), World Intellectual Property Organization (WIPO), Convention on Biological Diversity (CBD) and World Health Organization (WHO), and that in those organization observers did not have to base their comments on an oral report. He recalled that APBREBES' "Comparative Analysis across Selected International Organizations" had concluded that UPOV was substantially more restrictive regarding observers and access to documents compared to other organizations. To change that situation, the representative of APBREBES requested free access to all documents that serve as a basis for decisions of UPOV bodies and access for observers to the Consultative Committee. He was of the view that, with such a change, UPOV would open up its work to adhere to international standards of transparency, equity, inclusiveness and good governance. To be really inclusive, he suggested that UPOV should encourage the participation of farmers, civil society and other stakeholders. He noted that UPOV had a close cooperation with the seed industry and that if UPOV wanted to promote only plant variety protection it could continue with the current system, but if UPOV's aim was to promote a system of plant variety protection taking into account aspects of food security, development, agricultural biodiversity, a system for the future and for the benefit of society, UPOV should become much more inclusive. He noted that the UPOV Symposium to be held on October 21, 2011, had several presentations by the seed industry but no farmer or civil society group had been invited to present its views about the future of plant breeding. He was of the opinion that such an approach was like discussing the future of a market but without the customer, thus giving a restrictive view of the reality and not an optimal basis for future decisions.

\*12. The Council noted the comments made by the Association for Plant Breeding for the Benefit of Society (APBREBES).

\*15. The Council noted that the Administrative and Legal Committee (CAJ), at its sixty-fourth session held in Geneva on October 17, 2011, had approved the revision of document TGP/7/2, as presented in Annex I to document C/45/13.

\*16. The Council adopted the revision of document TGP/7 “Development of Test Guidelines” (document TGP/7/3), on the basis of the proposed amendments to document TGP/7/2, as presented in Annex I to document C/45/13.

*TGP/11/1 Examination of Stability (document TGP/11/1 Draft 11)*

\*17. The Council adopted document TGP/11/1 “Examination of Stability” on the basis of document TGP/11/1 Draft 11.

*TGP/0/4 List of TGP Documents and Latest Issue Dates (Revision)*

\*18. The Council adopted document TGP/0/4 “List of TGP Documents and Latest Issue Dates” on the basis of document TGP/0/4 Draft 1.

*UPOV/INF/6/2 Guidance for the Preparation of Laws Based on the 1991 Act of the UPOV Convention (Revision) (document C/45/13, Annex II)*

\*19. The Council adopted the revision of document UPOV/INF/6 “Guidance for the preparation of laws based on the 1991 Act of the UPOV Convention” (document UPOV/INF/6/2), on the basis of the amendments to document UPOV/INF/6/1, as presented in Annex II to document C/45/13.

*UPOV/INF/16/2 Exchangeable Software (Revision) (document C/45/13, Annex III)*

\*20. The Council noted that the CAJ, at its sixty-fourth session, had approved the revision of document UPOV/INF/16, as presented in Annex III to document C/45/13.

\*21. The Council adopted the revision of document UPOV/INF/16 “Exchangeable Software” (document UPOV/INF/16/2), on the basis of the proposed amendments to document UPOV/INF/16/1, as presented in Annex III to document C/45/13.

*UPOV/INF-EXN/I List of INF-EXN Documents and Latest Issue Dates  
(document UPOV/INF-EXN/I Draft 1)*

\*22. The Council adopted document UPOV/INF-EXN/1 “List of INF-EXN Documents and Latest Issue Dates” on the basis of document UPOV/INF-EXN/1 Draft 1.

*BMT/DUS/1 Possible use of Biochemical and Molecular Markers in the Examination of Distinctness, Uniformity and Stability (DUS) (document BMT/DUS/1 Draft 6)*

\*23. The Council adopted document BMT/DUS/1 “Possible use of Biochemical and Molecular Markers in the Examination of Distinctness, Uniformity and Stability (DUS)” on the basis of document BMT/DUS/1 Draft 6.

Examination and approval of the Draft Program and Budget of the Union for the 2012-2013 Biennium

\*24. The Council adopted the proposals contained in the Revised Draft Program and Budget for the 2012-2013 Biennium, as set out in document C/45/4 Rev., including the amount of contributions from members of the Union, the proposed maximum ceiling of expenditure in the regular budget, and the total number of posts for the Office of the Union.

Interim financial statement for 2010; arrears in contributions as of September 30, 2011

\*25. The Council considered document C/45/11 and noted the interim financial statement for 2010.

\*26. The Council noted the status of payment of contributions and the Working Capital Fund participations as at September 30, 2011, and noted that due to recent payments, Jordan and Viet Nam had no arrears. The Council noted that the European Union had made a recent payment leaving only a balance of 50,403 Swiss francs.

Designation of the External Auditor of UPOV

\*27. The Council considered documents C/45/14 and C/45/14 Add.

\*28. The Council designated Switzerland as auditor of the accounts of UPOV for a term of office of six years starting from January 2012.

\*29. The Council expressed its gratitude to Switzerland for its agreement to be designated as auditor of the accounts of UPOV.

Fiftieth Anniversary of the UPOV Convention

\*30. The Council noted the plans for the Fiftieth Anniversary of the UPOV Convention, as set out in document C/45/15.

31. On the occasion of the celebration of the Fiftieth Anniversary of the UPOV Convention, the Delegations of Belarus, China and the Republic of Moldova presented gifts of art to UPOV, the Delegation of the Russian Federation presented a letter from the Minister for Agriculture to the Secretary-General and a number of delegations expressed their congratulations to UPOV.

\*32. The Council expressed its appreciation for the messages of congratulation and the gifts presented by members of the Union in celebration of the Fiftieth Anniversary of the UPOV Convention.

Annual report of the Secretary-General for 2010; Report on activities during the first nine months of 2011

\*33. The Council noted the report of the Secretary-General on the activities of the Union in 2010, as provided in document C/45/2.

\*34. The Council noted the report on activities during the first nine months of 2011, as provided in document C/45/3.

\*35. The Council welcomed the increased cooperation between UPOV and the World Intellectual Property Organization (WIPO), in particular in relation to information technology.

Progress report of the work of the Administrative and Legal Committee

\*36. The Council noted the work of the CAJ, as provided in document C/45/9 and in the oral report made by the Chair of the CAJ, and approved the work program for the sixty-fifth session of the CAJ, as presented in the oral report of the Chair of the CAJ.

Progress report of the work of the Technical Committee, the Technical Working Parties and the Working Group on Biochemical and Molecular Techniques, and DNA-Profiling in Particular

\*37. The Council noted the work of the Technical Committee (TC), the Technical Working Parties and the Working Group on Biochemical and Molecular Techniques, and DNA-Profiling in Particular, as provided in document C/45/10, and approved the programs of work set out in document C/45/10.

Calendar of meetings in 2012

\*38. The Council approved the calendar of meeting, as set out in document C/45/8, with the following additional information:

(a) the reference to the Editorial Committee on the morning of March 26, 2012 should be removed;

(b) a “Symposium on the benefits of plant variety protection for farmers and growers” would be organized on November 2, 2012;

(c) the third meeting of the Working Group on Rules Concerning Observers would take place on March 29, 2012 at 6.00 p.m.;

(d) subject to the endorsement of the Administrative and Legal Committee (CAJ), at its sixty-fifth session to be held in Geneva on March 29, 2012, it was agreed that the sixty-sixth session of the CAJ would take place on the morning of October 29, 2012, and that the seventh session of the Administrative and Legal Committee Advisory Group (CAJ-AG) would be held on the afternoon of October 29 and on October 30, 2012; and

(e) the dates for the sessions to be held in Geneva in 2013 would be from March 18 to 22 and from October 21 to 25.

#### Election of new Chairpersons

\*39. The Council elected, in each case for a term of three years ending with the forty-eighth ordinary session of the Council, in 2014:

- (a) Mrs. Robyn Hierse (South Africa), Chairperson, Technical Working Party for Agricultural Crops (TWA);
- (b) Mr. Sami Markkanen (Finland), Chairman, Technical Working Party on Automation and Computer Programs (TWC);
- (c) Mrs. Carensa Petzer (South Africa), Chairperson, Technical Working Party for Fruit Crops (TWF);
- (d) Mr. Nik Hulse (Australia), Chairman, Technical Working Party for Ornamental Plants and Forest Trees (TWO);
- (e) Mr. François Boulineau (France), Chairman, Technical Working Party for Vegetables (TWV); and
- (f) Mr. Alejandro Barrientos Priego (Mexico), Chairman, Working Group on Biochemical and Molecular Techniques and DNA-Profiling in Particular (BMT).

#### Situation in the legislative, administrative and technical fields:

\*40. The Council considered documents C/45/16, C/45/5, C/45/6 and C/45/7. It noted that an addendum of document C/45/16 would be produced and that a revision of document C/44/7 concerning statistics for the period 2005-2009 had been published on the UPOV website (document C/44/7 Rev.).

\*41. The Council considered and approved the draft press release that was distributed at the end of its forty-fifth ordinary session. The Press Release approved by the Council is reproduced in Annex [III] to this report.

Retirement

42. The President noted that Ms. Nicole Bustin (France) would retire before the subsequent session of the Council. The President expressed his thanks to Ms. Bustin, on behalf of the Council, for her contribution to the work of the Union and wished her a long and happy retirement.

## ANNEX II

INTERVENTION BY AMBASSADOR FERNANDO ROJAS SAMANEZ,  
PERMANENT REPRESENTATIVE OF PERU

Thank you very much, Mr. Chair.

It is a great honor for me to take the floor at this session of the Council in order to convey the profound satisfaction and gratitude of the Government of Peru for the warm welcome given to us by UPOV. Being a member of this Union is undoubtedly a great honor and an important challenge.

During what was almost a two-year process, Peru deposited its instrument of accession to the UPOV Convention (1991 Act) on July 8, 2011, and became the 70<sup>th</sup> member of the Union on August 8, 2011.

This accession is a clear demonstration of my country's commitment to the principles and aims of the Convention, which seeks to promote an effective system for the protection of new varieties of plants, with a view to promoting the development of new varieties for the benefit of society.

We are fully convinced that the effective use of these types of mechanisms for protection and promotion is a key factor in continuing on the path toward growth and development, to the extent that it will promote innovation, development and the exchange of technology and agricultural research, with the aim of consolidating a sustainable production system.

This is the vision held by my country in relation to how to make the most of the benefits inherent in a protection regime of this nature. For that reason, in 1993 Peru supported the adoption of a system of protection for the rights of breeders of plant varieties within the Andean Community, through Decision 345 of the Cartagena Agreement Commission. We have recently developed the "Regulations for Protection of the Rights of Breeders of New Varieties of Plants", thereby consolidating the normative framework applicable to the rights of breeders in Peru.

At the national level, breeder's rights lie within the remit of the National Institute for the Defense of Competition and Protection of Intellectual Property (INDECOPI) and the National Institute for Agricultural Innovation (INIA). Within their respective remits, both institutions are responsible for ensuring respect for and the application of breeder's rights, and have available an appropriate legal and institutional framework to ensure the operation of the protection system.

Mr. Chair,

These are then some of the scopes and efforts undertaken at the national level in relation to the protection of new varieties of plants. It should be recognized that although much progress has been made in this regard, there still remains a lot of work to be done, especially now that we have acceded to this important Convention.

In the next few months, our country will have to make a start on the work to disseminate the Convention and its benefits among the potential users of the system, mainly within the country, which contains precisely one of the major sources of biodiversity on the planet. Similarly, the competent national authorities shall focus their efforts on supporting and fostering agricultural research, such that the development of more new varieties of plants eligible for protection in Peru may be promoted.

In order to achieve said aims, we hope to enjoy the valuable support and cooperation of the Office of the Union and its members, especially those in a position to provide both technical and financial assistance.

Finally, Mr. Chair, I would like to place on record our profound gratitude to the Office of the Union for the important and valuable help which it has given us during the process of accession to the UPOV Convention. Equally, I would like to express our recognition to the experts from our country and to the authorities of other members of the Union for their help and cooperation.

UPOV Council Sets Biennial Program, Marks 50th Anniversary of the UPOV Convention

The Council of the International Union for the Protection of New Varieties of Plants (UPOV) met in Geneva on October 20, 2011, in the year of the 50<sup>th</sup> anniversary of the UPOV Convention, to take stock of the Union's work over the past year and approve the next biennium's program and budget.

UPOV members acknowledged that the 50<sup>th</sup> anniversary of UPOV comes at a time when a changing world carries many challenges for agriculture. At the global level, increasing population, climate change, parallel demands for food and energy production and evolving human needs require a response in agricultural production, often at the same time as land and inputs become increasingly scarce and expensive. Success in responding to these challenges relies on dynamic and sustainable agriculture.

Plant Breeding has significantly contributed and will continue to be a major contributor to increased food security whilst reducing input costs, greenhouse gas emissions and deforestation. With that, plant breeding significantly mitigates the effects of population growth, climate change and other social and physical challenges.

Innovation in agriculture and horticulture is important for economic development in the rural sector. Production of high value varieties of ornamentals, fruit and vegetables provide employment and income for hundreds of thousands – even millions – of people. An effective system of plant variety protection is crucial for a sustainable contribution of plant breeding and seed supply and is a key enabler for investment in breeding and the development of new varieties of plants. UPOV membership promotes economic and social benefits and is an important global signal for breeders to have the confidence to introduce their new varieties in that country, which will be of benefit to farmers and growers in the country.

To mark the 50th anniversary, UPOV organized the “Symposium on Plant Breeding for the Future”, on October 21, 2011, which reviewed recent developments in plant science and looked forward to the challenges and opportunities for applying those scientific developments in plant breeding ([http://www.upov.int/meetings/en/details.jsp?meeting\\_id=24133](http://www.upov.int/meetings/en/details.jsp?meeting_id=24133)).

Round-up of key developments in UPOV Council:

*New members of the Union*

The Council was informed that Peru had deposited its instrument of accession to the UPOV Convention and became the 70<sup>th</sup> member of UPOV on August 8, 2011.

*Program & Budget*

The Council approved the Program and Budget for the 2012-2013 biennium, amounting to Sfr6,798,000. This budget contains no change in the value of the contribution unit by members of the Union and no change in the total number of posts for the Office of the Union.

*Information on UPOV*

Plans for the launch of a redesigned website on November 1, 2011, were approved with the aim of improving the availability of information on UPOV to a range of users. Some of the features of the redesigned website include the following:

- freely accessible database of plant varieties (PLUTO), formerly only available in the form of a CD-ROM on subscription
- multimedia presentation on UPOV
- video on the use of plant variety protection by gentian farmers in the Ashiro region of Japan (“the Ashiro Rindo story”)
- launch of UPOV YouTube channel
- UPOV collection of materials explaining the UPOV system
- database of UPOV members’ laws (UPOV Lex)

*Public Access to UPOV Documents*

In a further move to increase access to documents, the Council agreed that the documents of the Administrative and Legal Committee (CAJ), Technical Committee (TC) and Technical Working Parties (TWPs), which were formerly only accessible to members and observers, would be made publicly accessible.

*Cooperation with ITPGRFA*

The Council agreed with the request of the secretariat of the International Treaty on Plant Genetic Resources for Food and Agriculture for the Office of the Union to cooperate with ITPGRFA on a research project on the economics of the Multilateral System of the ITPGRFA, based on information available from the Plant Variety Database (PLUTO).

*Other*

The observer status for the Asia and Pacific Seed Association (APSA) was extended to the Administrative and Legal Committee (CAJ), Technical Committee (TC) and Technical Working Parties (TWPs).

*Plant Variety Protection Statistics*

The Council noted a record number of plant variety protection titles granted in 2010, with the number exceeding 11,000 for the first time (a 3% increase on 2009). A record number of titles in force – 90,214 – was recorded in 2010, representing a 4 percent increase on figures for 2009.

*Cooperation in the Examination of New Plant Varieties*

In 2011, the number of plant genera and species for which there were agreements between members of the Union for cooperation in the examination of distinctness, uniformity and stability totaled 1,990, compared to 1,400 in 2010.
