TENTATIVE DATES FOR MEETINGS IN 1975

Report by the Secretariat

1. Experience has shown that it is difficult to find a room for UPOV meetings in the WIPO building if the dates of the meetings are not fixed far in advance. The renting of meeting rooms outside the WIPO building involves extra and unnecessary expense for UPOV.
2. The Secretariat of UPOV has therefore tentatively fixed the dates listed in the Annex for possible UPOV meetings in 1975 and has asked the administrative services of WIPO provisionally to reserve meeting rooms for those dates.
3. In tentatively fixing the said dates, the Secretariat does not in any way wish to prejudice the competent bodies of UPOV. It is understood that those bodies are free to decide to hold their meetings on other dates. Neither will the list of tentative dates prejudice the question whether such meetings will be held in 1975 at all.
4. The list also includes the dates for meetings of the Technical Working Parties already known to the Secretariat.
