TENTATIVE DATES FOR SESSIONS IN 1977

proposals made by the Office of the Union

1. The Office of the Union has, as in the previous years, tentatively fixed the dates listed in the Annex for possible UPOV sessions in 1977 and has asked the administrative services of WIPO to reserve meeting rooms for those dates.

2. In tentatively fixing the said dates, the Office does not in any way wish to prejudice the competent bodies of UPOV. It is understood that those bodies are free to decide to hold their sessions on other dates. Neither will the list of tentative dates prejudice the question whether such sessions will be held in 1977 at all.
