GUIDANCE CONCERNING INFORMATION, DOCUMENTS OR MATERIAL FURNISHED BY THE BREEDER FOR EXAMINATION PURPOSES AND FOR VERIFYING THE MAINTENANCE OF VARIETIES

Document prepared by the Office of the Union

- 1. At its fiftieth session, on October 18 and 19, 2004, the Administrative and Legal Committee (CAJ) discussed document CAJ/50/2 "Draft recommendations concerning information, documents or material furnished for examination purposes" (draft recommendations). See paragraphs 1 to 7 of document CAJ/50/2 to obtain information on the historical background of the draft recommendations.
- 2. The CAJ agreed that a new version of document CAJ/50/2 should be prepared for the April session of the CAJ in 2005, taking into account the comments made at its October session in 2004 (see paragraphs 65 to 160 of document CAJ/50/7 Prov.).
- 3. The new version of document CAJ/50/2, which is presented as the Annex to this document, makes direct reference to the relevant provisions of the 1991 Act of the UPOV Convention where the authority may require the breeder to furnish necessary information, documents or material. This requirement is contained in Article 12, as regards examination purposes, and also in Article 22(1)(b)(i) for verification of the maintenance of the variety. As a consequence, the title of the new version of the draft document in the Annex has been changed to: "Guidance concerning information, documents or material furnished by the breeder for examination purposes and for verifying the maintenance of varieties".

- 4. During the consideration of document CAJ/50/2, a discussion took place on the nature of the document. It was agreed that the document should provide clear guidance for existing and future members of the Union by means of a checklist or control list with the required degree of flexibility and without prejudice to the applicable law.
- 5. The Annex to this document includes guidance, mainly in a table form, on matters concerning the handling by authorities of information, documents and material furnished by breeders for examination purposes and for verifying the maintenance of varieties in the context of a plant breeder's right scheme in accordance with the UPOV Convention.
  - 6. The CAJ is invited to consider and comment on the proposed "Guidance concerning information, documents or material furnished by the breeder for examination purposes and for verifying the maintenance of varieties" in the Annex to this document.

# GUIDANCE CONCERNING INFORMATION, DOCUMENTS OR MATERIAL FURNISHED BY THE BREEDER FOR EXAMINATION PURPOSES AND FOR VERIFYING THE MAINTENANCE OF VARIETIES

# Introduction

1. Without prejudice to applicable law and international treaties, the guidance in this document relates to the handling of information, documents and material furnished by breeders<sup>1</sup> to authorities<sup>1</sup> for examination purposes or for verifying the maintenance of varieties in the context of a plant breeder's right scheme in accordance with the UPOV Convention (see Article 12 and Article 22(1)(b)(i) of the 1991 Act of the UPOV Convention).

### *Obligations of Authorities*

- 2. In drafting guidance concerning information, documents or material furnished by the breeder for examination purposes or for verifying the maintenance of varieties, it is recognized that the authority is required to act in accordance with its public service status. That status carries obligations with regard to its handling of information, documents and material and the safeguarding of the legitimate interests of the breeder. In particular, authorities are required to take the necessary measures to avoid the unauthorized removal and/or the misuse of information, documents and material.
- 3. In general, unless otherwise agreed with the breeder, the authority should only use information, documents and material of varieties, furnished by the breeder, for its activities concerning the examination of plant breeders' rights applications and verification of the maintenance of varieties, as appropriate.
- 4. The authority should follow the "UPOV Recommendations to ensure the independence of those DUS examination centers which have, or have links to, breeding activities" (draft document in CAJ/49/3).

# Court Proceedings

5. Information, documents and material furnished by the breeder or generated by the authority concerning applications for and grants of breeders' rights might be requested in the context of court proceedings.

Reference in this document to the terms "breeder" and "authority" should be understood as defined in Article 1(iv) and (ix), respectively, of the 1991 Act of the UPOV Convention.

### Guidance

- 6. It is for each authority to decide which information, documents or material furnished by the breeder it publishes (e.g. in its official gazette), makes available to the public on request or to other authorities. The following table is intended to provide some guidance where sought by authorities.
- 7. The Table should be read as follows: grey boxes should be understood as "not appropriate"; columns referring to "available to DUS examiners in other territories" cover situations where the DUS examination is not conducted by the authority itself; footnotes in the Table relate to UPOV documents used as a reference (e.g. <sup>a, b, c</sup>...); additional information indicated by a corresponding note (e.g. <sup>see note 1, 2, 3...</sup>) has been incorporated in the Appendix at the end of the Table (notes in the Appendix should be read in conjunction with the following Table).

#### 5(b) RESIDUE of the TRIAL using MATERIAL of the CANDIDATE VARIETY furnished by the BREEDER (see note 5)

Once the examination is complete, authorities are encouraged to destroy [or return to the breeder] the residue of the trial using material of the candidate variety furnished by the breeder, unless otherwise agreed with the breeder.

# 5(c) MATERIAL NOT of the CANDIDATE VARIETY furnished by the BREEDER (see note 5)

Authorities are encouraged to destroy or return to the breeder all material not of the candidate variety furnished by the breeder, unless otherwise agreed with the breeder.

# 7(b) <u>RESIDUE of the TRIAL using MATERIAL of the PROTECTED VARIETY furnished by the BREEDER for VERIFYING the MAINTENANCE of the PROTECTED VARIETY</u> (see note 10)

Once the verification is complete, authorities are encouraged to destroy [or return to the breeder] the residue of the trial using material of the protected variety furnished by the breeder, unless otherwise agreed with the breeder.

### 7(c) MATERIAL NOT of the PROTECTED VARIETY furnished by the BREEDER for VERIFYING the MAINTENANCE of the PROTECTED VARIETY (see note 10)

Authorities are encouraged to destroy or return to the breeder all material not of the protected variety furnished by the breeder for verifying the maintenance of the protected variety, unless otherwise agreed with the breeder.

#### **APPENDIX**

# NOTES OF THE TABLE ON INFORMATION, DOCUMENTS OR MATERIAL FURNISHED BY THE BREEDER FOR EXAMINATION PURPOSES AND FOR VERYING THE MAINTENANCE OF VARIETIES

# **Publication**

- Note 1: Sections 1 to 4 of the Table refers to information published by the authority (e.g. in its Official Gazette), including:
- (a) information concerning applications for, and grants of, breeders' rights and proposed and approved denominations (Article 30(1)(iii) of the 1991 Act, Article 30(1)(c) of the 1978 Act of the UPOV Convention). See also the UPOV Model Plant Breeders' Rights Gazette (UPOV/INF/5 (UPOV Pub. 644(E) Section 9)) and UPOV Model Form for the Application for Plant Breeders' Right (TGP/5: Section 2 (Annexes II and IV, Part I of document C/XVIII/9 Add.) (UPOV Publication No. 644(E), Section 10));
- (b) other information which may be mandatory under the applicable law: for example, changes in persons (applicants, holders and procedural representatives, etc.).

### **UPOV Publications**

Note 2: The column "UPOV Publications" in Sections 1 to 3 of the Table refers to information submitted by authorities as a contribution to UPOV documents and publications including, in particular, the Plant Variety Database (UPOV-ROM) which contains data on applications for plant breeders' rights, proposed and approved denominations, relevant parties and information regarding equivalent applications in the territories of other authorities.

# **Variety Denominations**

Note 3: Authorities are required to inform other members of the Union on matters concerning variety denominations, in particular the submission, registration and cancellation of denominations (see Article 20(6) of the 1991 Act, Article 13(6) of the 1978 Act of the UPOV Convention and UPOV Model Plant Breeders' Rights Gazette) (see Section 2 "Variety denomination information" of the Table).

# **Growing Trials**

Note 4: In Section 4 "DUS Examination" of the Table, reference is made to growing trials. Consideration should be given to whether the opportunity to visit growing trials would be given to all or only to some aspects of the growing trials. In particular, the authority may avoid any access to the part of a growing trial which contains material of parent lines submitted in relation to an application for a hybrid variety. Furthermore, for example, the opportunity to visit might be limited to some part of the trial, to a particular pair of varieties in the trial or to general information about the trial (trial design, location, etc.) and the varieties in the trial might be coded. Particular measures should be taken to avoid the removal of material during such visits.

# Material of Parent Lines Furnished by the Breeder in Relation to an Application for a Hybrid Variety

Note 5: Guidance in the Table, in particular in Section 5, refers only to material of the candidate variety. In the case of material of parent lines submitted as a part of the examination of a candidate hybrid variety, material should only be made available to other authorities and other DUS examiners in such a way that the legitimate interests of the breeder would be safeguarded. Unless agreed otherwise by the breeder, arrangements for such exchange should only concern parent lines of hybrid varieties which have been granted plant breeders' rights (PBR) or for which PBR have expired and the breeder should be notified accordingly.

#### Candidate Varieties

Note 6: In the case of varieties for which an application is under examination, particular consideration should be given with respect to providing material to other authorities in relation to safeguarding the legitimate interests of the breeder. Authorities may, for example, decide not to provide material of candidate varieties or may decide to provide material of a candidate variety on the basis that the material is destroyed or returned to the breeder if the application does not lead to the granting of a breeder's right (see Section 5(a) of the Table "Material of the Candidate Variety Furnished by the Breeder"). Arrangements for such exchange concerning candidate varieties should be subject to formal agreements between authorities and the breeders should be notified accordingly (see Model Administrative Agreement for International Cooperation in the Testing of Varieties (TGP 5: Section 1 (Annex III of document C/27/15) (UPOV Pub. 644(E) Section 19)).

#### Protected Varieties

Note 7: In respect of protected varieties, authorities are encouraged to exchange information, documents and material furnished by the breeder for examination purposes or for verifying the maintenance of varieties, in ways which will ensure the effective grant of breeders' rights and which safeguard the legitimate interests of the breeders.

# <u>Material Available for Purposes other than Examination Purposes and the Verification of the Maintenance of Varieties</u>

Note 8: The authority should take appropriate measures to ensure that material furnished to it for examination purposes or for verifying the maintenance of varieties is not used for breeding purposes without the authorization of the breeder.

Note 9: Notwithstanding Note 8, in a case where an authority makes material furnished to it available for other purposes (e.g. for inclusion in a gene bank) after the termination of the breeder's right, the authority should differentiate between material of the variety which is the subject of the plant breeder's right and other material, for example material of parent lines submitted in connection with an application for a hybrid variety, which it is encouraged to destroy or return to the breeder.

<u>Material of Parent Lines Furnished by a Breeder for Verifying the Maintenance of a Protected Hybrid Variety</u>

Note 10: The principle explained in Note 5 also applies to material of parent lines furnished by a breeder for verifying the maintenance of a protected hybrid variety.
