ORDER OF THE PROVISIONS

Document prepared by the Office of the Union

1. The annex to this document contains a revised version of the proposal from the delegation of the Federal Republic of Germany concerning the structure of the Convention. Some amendments to the previous version (document CAJ/27/3) proposed by the said delegation are incorporated. The Office of the Union has updated and adapted the document to the most recent text proposed for the new Act of the Convention (documents IOM/5/2 and IOM/5/3).

2. It is recalled that the Administrative and Legal Committee decided at its twenty-seventh session on the following procedure: the Office of the Union was to establish the said proposed text on the basis of the order retained in document CAJ/27/2 and CAJ/27/4; it should prepare the final text after this, the twenty-eighth, session on the basis of the order agreed in this session; that final text would then be submitted to the Council for its approval to the submission of the text to the Diplomatic Conference. Document CAJ/27/3 contains further information on the history of this subject.
