1. The annex to this document contains a first draft of the provisional agenda of the 1991 Diplomatic Conference for the Revision of the UPOV Convention.
2. The first draft is broadly similar to the provisional agenda of the 1978 Diplomatic Conference, which had been adopted without amendment. It differs in particular by the reversed order of the first two items and the addition of two items relating to opening and closing declarations.

3. The Administrative and Legal Committee is invited to approve the submission of the first draft of the provisional agenda of the Diplomatic Conference to the twenty-fourth ordinary session of the Council for adoption.
