### UPOV MODEL FORM FOR THE TRANSMITTAL OF EXAMINATION RESULTS

### Document prepared by the Office of the Union

- 1. At its second session, the Administrative and Legal Committee considered a draft model form for the transmittal of examination results and asked the Office of the Union to prepare a new proposal (see document CAJ/II/8, paragraph 19).
- 2. The new proposal appears in the Annex to this document. Explanations thereon are given below.
- 3. The proposed model form follows the pattern of the UPOV Model Form for the Request of Examination Results already adopted (see the Annex to document C/XI/5), in that it is drafted in the form of a letter. Each national authority would thus establish its own standard letter under its own letter-head. It would also decide how to address the receiving authority.
- 4. The proposed model form allows for one single form to cover the transmittal of several reports. For this reason, the data on each report would be presented in tabular form. It is proposed that the following data be indicated: species to which the report or reports relate(s); application number; (proposed or approved) denomination or breeder's reference. Although the application number would be sufficient to identify the report, it is proposed that the denomination (or the breeder's reference) be given as a check.
- 5. Article 4(1) of the UPOV Model Agreement for International Cooperation in the Testing of Varieties provides for the submission of a report after each testing period (interim report) and a final examination report. The proposed model form thus provides for the indication of the type of report transmitted.
- 6. Since one single form can cover the transmittal of several reports, it would be useful to indicate separately the fee payable for each report. If so desired, details of the composition of such fee would be given as shown in the Annex. Should the fee include costs which are not specifically mentioned in the schedule of fees, for instance the costs of special tests, explanations should be given in the item "remarks."
- 7. The conditions of payment would be indicated by each authority and should include details on the available means of settlement and the deadline for payment.
