1. The Fourth Meeting with International Organizations, scheduled to be held on October 9, 1989, will have on its agenda one point only, the revision of the Convention (unless otherwise decided by the Consultative Committee).

2. Two international non-governmental organizations that are regularly invited to the meetings with international organizations, ASSINSEL and FIS, will hold their annual congress at the end of May and beginning of June, i.e. in the seventh week following the present session of the Administrative and Legal Committee. In view of the time required for the preparation and distribution of documents, and for consultations within national professional organizations, the Office of the Union proposes that the documentation for the Fourth Meeting with International Organizations be constituted as follows:

(i) If the discussions of the Administrative and Legal Committee result only in a limited number of amendments to be made to document CAJ/XXIV/2 to bring it up-to-date, the documentation could be made up by that document, as updated.

(ii) If the discussions result in a greater volume of amendments, it would be preferable to submit to the organizations document CAJ/XXIV/2 without changes, together with summary indications on the main amendments.

3. The Committee is invited to make a recommendation to the Consultative Committee on the matter examined above.
