DocumentpreparedbytheOfficeo ftheUnion

1. At its thirty -eighth session, held in Geneva from April 15 to 17, 2002, the Technical Committee (hereinafter referred to as "the TC") discussed the possibility of holding a preparatory workshop before each Technical Working Party (hereinafter referred to as "the TWP") meeting, with the aim of helping some of the delegates to participate more actively at the meeting. The TC agreed that the Office of the Union (hereinafter referred to as "the Office") should seek to organize prepar atory workshops for the TWP sessions to be held in 2002 and report he outcome to the TC attist thirty -ninth session in 2003. The purpose of this document is to provide the report requested by the TC.

#### Background

2. FortheTCsessioninApril 2002,theOfficepreparedadocument(documentTC/38/12) containing aproposal for a preparatory workshop to be held before the TWP meetings, on the basis that such a workshop might help some of the delegates to participate more actively at the meeting. In particular, it was noted that a preparatory workshop could provide participants with an opportunity to see k clarification of matters on the agenda in a less formalsituation and with more time to resolve any language difficulties. The preparatory works hop could also offer the possibility for participants to indicate certain to pics where the ywould like to make a contribution, but would normally feel inhibited by the pace of discussions. There would then be the possibility for the Chairman to ensure tha tthe participant is given a clear opportunity to speak on the issues at the appropriate time. Alternatively, if preferred, contributionstobemadeatthemeetingmightbedonesothroughtheChairmanortheOffice.

3. The document suggested the at, for practical and economic reasons, the preparatory workshops would be organized for the Sunday immediately preceding the relevant TWP meeting. Invitations to this preparatory workshop would be sent with the official invitationtotherelevantTWPmee ting. Thesession would be organized by the Office but, to ensure the session was most effective, the Chairman of the relevant TWP was to be encouraged to attend. In addition, other experienced participants would be encouraged to attend to attend to attend the preparatory workshop would be encouraged to attend.

5. Apreparatorywork shopwasheldpriortoeachTWPmeeting, with the exception of the Technical Working Party on Automation and Computer Programs (TWC). In the case of the TWC, a workshop on data handling took place the week before the TWC meeting and included the elements in the preparatory workshop.
