ADDENDUM TO "UPOV INFORMATION DATABASES"

Document prepared by the Office of the Union

1. On November 25, 2008, the Office wrote to members of the Union and contributors to the UPOV-ROM that do not currently provide data for the UPOV-ROM, do not provide data on a regular basis, or do not provide data with UPOV codes. In each case, the individual circumstances of the contributor were summarized and the recipient was invited to explain the type of assistance that would enable them to provide regular and complete data for the UPOV-ROM.

2. Annex II to document TC/45/6 lists the members of the Union and organizations that were contacted and summarized the developments in each case as of January 2009. However, document TC/45/6 explained that a number of members of the Union were in contact with the Office and a further update would be provided at the forty-fifth session of the TC and fifty-ninth session of the CAJ. The purpose of this document is to provide that update.
