

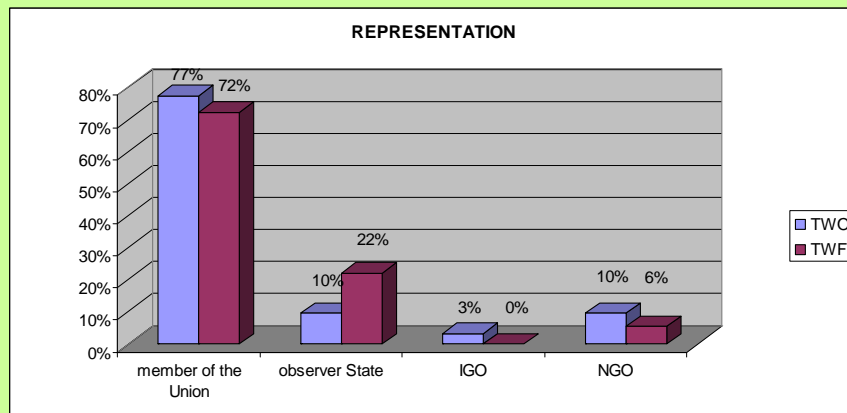

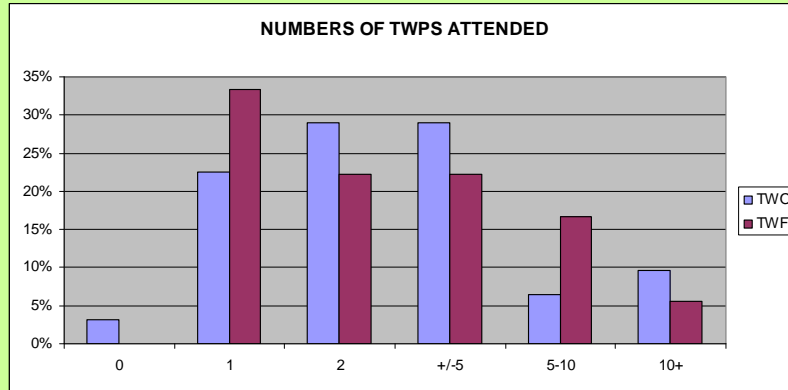

1- Are you representing ?

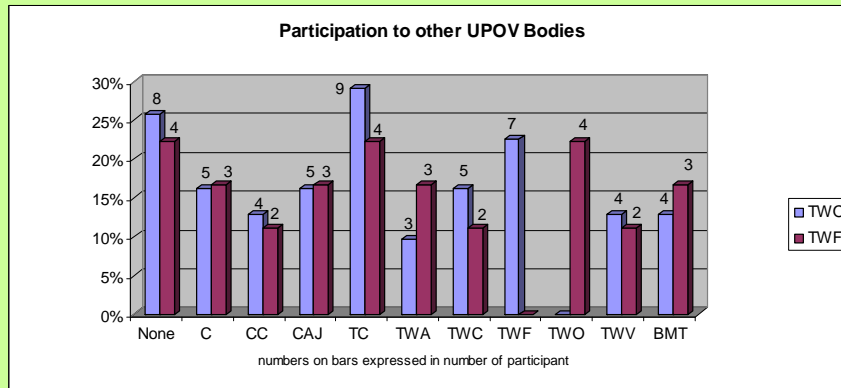


2- How many TWO meetings have you attended?

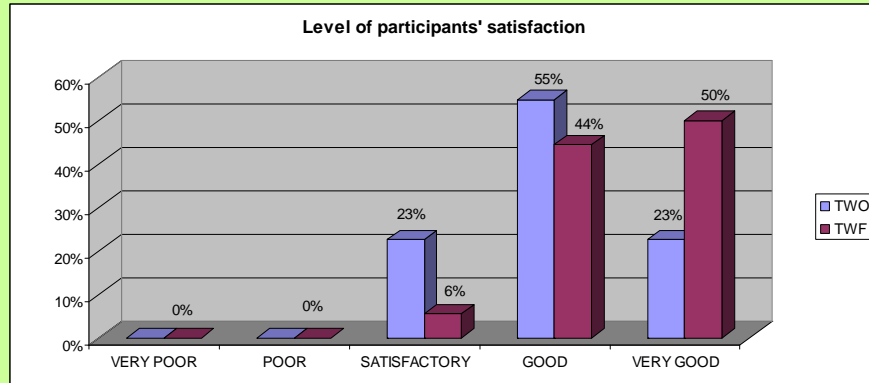

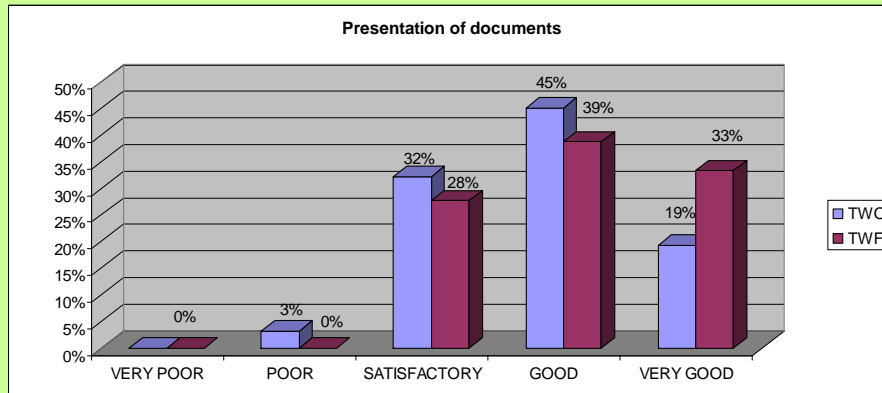

4- Did the venue meet your expectations (venue, equipment, access, rooms, food, price...)?



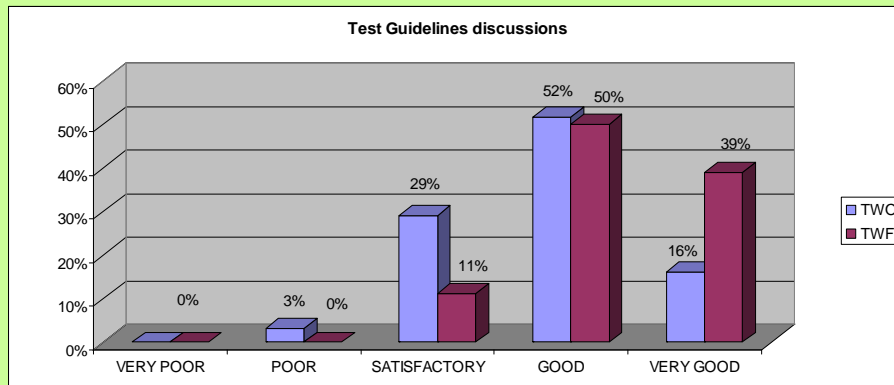

5- Are you satisfied with the way in which the general documents were presented at the TWP meetings?



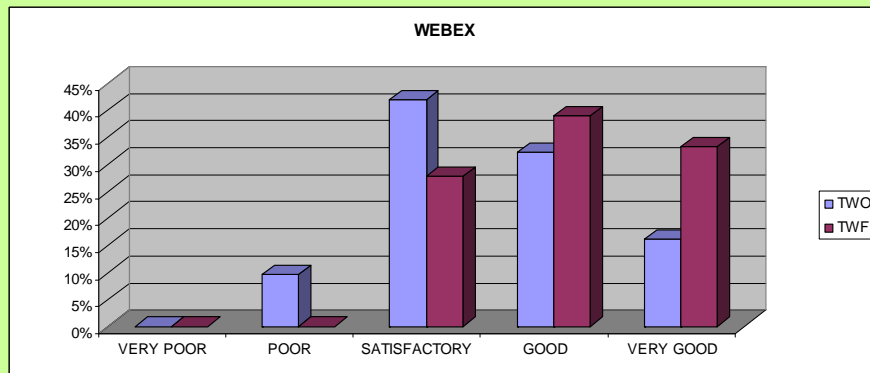

6- Are you satisfied with the way in which the Test Guidelines were presented/discussed at the TWP meetings ?



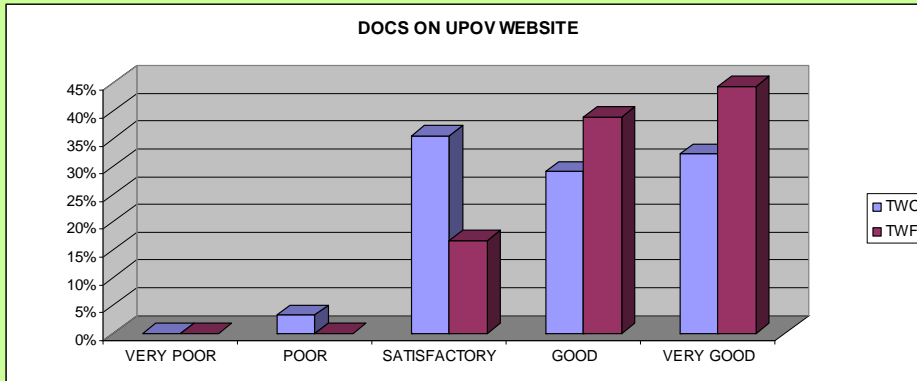

7- What is your opinion of the usefulness of the WebEx intervention ?

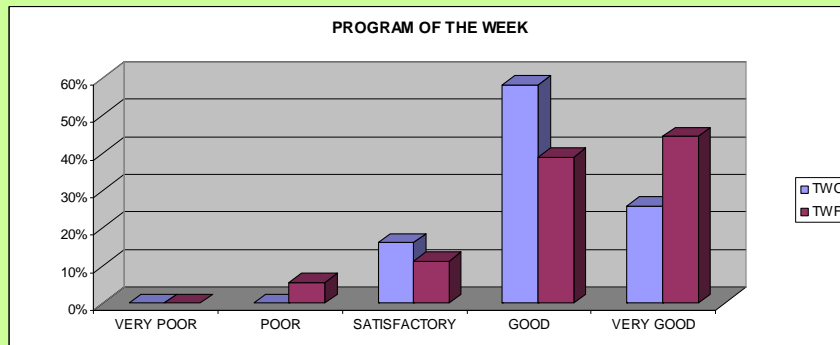
