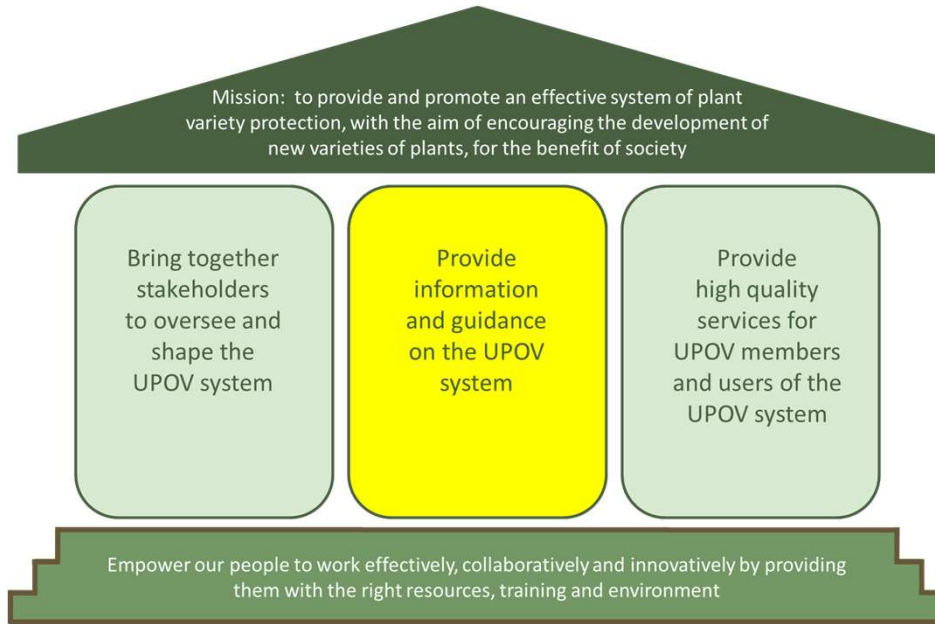




Number of missions, activities and meetings involving UPOV

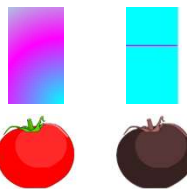
