## PARTIAL REVISION OF THE TEST GUIDELINES FOR CHRYSANTHEMUM

1. The purpose of this document is to present a proposal for a partial revision of the Test Guidelines for Chrysanthemum (document TG/26/5 Corr. 2).
2. The Technical Committee, at its fifty-fifth session, held in Geneva, on October 28 and 29, 2019, agreed to request the partial revision of the Test Guidelines for Chrysanthemum (document TG/26/5 Corr. 2) to expand the coverage to all varieties of *Chrysanthemum* L. (see document TC/55/25 Corr. "Report", paragraph 248).
3. The following changes are proposed:
  - (a) Name box on cover page
  - (b) Table with alternative names on cover page
  - (c) Chapter 1 "Coverage of these Test Guidelines"
  - (d) Chapter 10 "Technical Questionnaire", 1. "Subject of the Technical Questionnaire"
