PARTIAL REVISION OF THE TEST GUIDELINES FOR ONION (TG/46/7)

Document prepared by experts from the Netherlands

Background

- 1. At the forty-fourth Session of the Technical Committee (TC), held in Geneva from April 7 to 9, 2008 (see document TC/44/13 "Report", paragraph 189), the delegation of the Republic of Korea reported that it had identified an additional state of expression for characteristic 23 in the Test Guidelines for Onion TG/46/7(proj.5). It was agreed that that development should be considered by the Technical Working Party for Vegetables (TWV) at its session in 2008 but that, in the meantime, the Test Guidelines for Onion should be adopted on the basis of document TG/46/7(proj.5). The TC noted that an additional state of expression could be accommodated by a partial revision of the Test Guidelines at a subsequent TC session.
- 2. Characteristics 23, 24 and 25 of document TG/46/7 are reproduced here:

3. At its forty-second session held in Cracow, Poland, from June 23 to 27, 2008, (see document TWV/42/17 "Report", paragraph 72), the TWV agreed that Mr. Kees van Ettekoven (Netherlands) should organize an exchange of seed of potential example varieties for a possible new state 8 "purple" in characteristic 23 "Bulb/Bulblet: base color of dry skin" of the Test Guidelines for Onion, document TG/46/7. It was agreed that the Czech Republic, France, Italy, Netherlands, Republic of Korea, Spain and the United Kingdom would consider the varieties 'Boradongi', with seed to be supplied by the Republic of Korea, and 'Karmen', with seed to be supplied by the Czech Republic, in comparison to the existing example varieties 'Brunswijke' and 'Red Baron', to be provided by the Netherlands. It was agreed that the Netherlands would present the results of the exchange at the forty-fourth session of the TWV, in 2010.

Result of the Ring Test

4. Although characteristic 24 was not the subject of the ring test, some of the participants observed this characteristic and provided comments. Those results are also included in this summary of results. The results of France and the Republic of Korea were not received at the time of drafting the report. All other participants provided photographs of the varieties to illustrate the results.

- 5. It can be concluded that the majority of the participants observe 'Boradongi' and 'Karmen' to have a red (7) base color of dry skin (characteristic 23).
- 6. However, the hue of the color of dry skin seems to be less obvious. 'Karmen' and 'Red Baron' have a purple hue (8) according to the majority of participants. 'Brunswijker' has a red hue (7) or the hue is absent (1). It can be concluded that these two observations are in fact the same. For 'Boradongi' the notes given to the hue of color lead to the conclusion that this is a little less obvious, but the tendency is to describe it as pinkish.
- 7. When the intensity of base color of dry skin (characteristic 24) notes are taken into account (3 participants), it can be noted that 'Boradongi' is observed to have a lighter intensity than the other 3 varieties.

Proposal

8. Following the results and conclusions in paragraphs 5, 6 and 7, it is proposed to add 'Boradongi' as an example variety for state 7 "red" in characteristic 23. Furthermore, it is proposed to add example varieties with base color red, to characteristic 25, especially to the

states brownish (5), pinkish (6), reddish (7) and purplish (8). 'Red Baron' and 'Karmen' could be examples for purplish (8), 'Boradongi' for pinkish (6).

9. The proposal above (paragraphs 1 to 8) was circulated to the TWV by means of Circular E-1269 of April 26, 2010. No comments were received.
