- 1. This document contains, in its Annex, the preliminary draft of the Provisional Agenda of the Diplomatic Conference on the revision of the UPOV Convention, which is scheduled to be held in October 1978. It would bear the document number UPOV/78DC/1.
- 2. The said draft has been established on the basis of the Draft of the Provisional Rules of Procedure appearing in document IRC/VI/4. It conforms to practice and takes account of the experience gained from recent diplomatic conferences. It is on the basis of such experience that it is proposed:
- (i) that the first three items of the agenda be dealt with under the Chairmanship of the Secretary-General of UPOV, thus placing each Delegation in a position of strict equality during the adoption of the Rules of Procedure and the election of the President,
- (ii) that the Rules of Procedure be adopted before the election of the President of the Conference, thus ensuring that the said Rules be applicable without contestation to the said election,
- (iii) that the Credentials Committee establish two reports to be considered by the Conference, as all the credentials, full powers and letters or other documents of appointment are generally not available at the beginning of the Conference.
  - 3. The Committee of Experts is invited:
  - (i) to examine the preliminary draft of the Provisional Agenda,
  - (ii) to approve, subject to any amendment agreed upon, its submission to the Council at its eleventh ordinary session, to be held in December 1977, for final approval.

- 11. Consideration and adoption of any statement to be included in the Records of the Conference
- 12. Adoption of a final act, if any, of the Conference
- 13. Closing of the Conference by the President\*.
