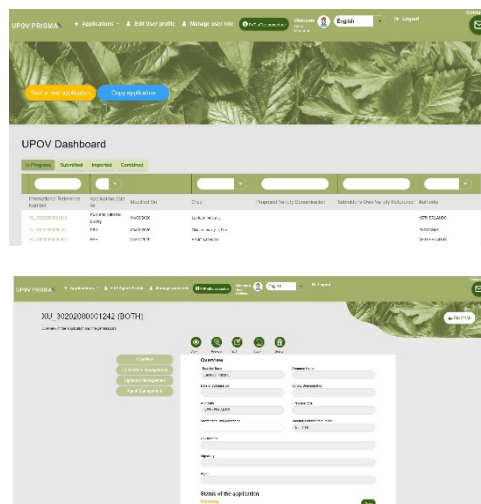
UPOV is pleased to announce the release of UPOV PRISMA, Version 2.4

RE-INTRODUCTION OF UPOV PRISMA FEE


The UPOV PRISMA fee will be **90 Swiss francs** per PVP application made using UPOV PRISMA. This fee is in addition to the PVP application fee(s) for the UPOV member concerned. (Note: For the United Kingdom, the UPOV PRISMA fee will be paid by the United Kingdom PVP Office.)

PARTICIPATING AUTHORITIES

35 UPOV members participate in UPOV PRISMA, including the European Union (CPVO) (European Union operates a PVP system covering its 27 Member States and until December 31, 2020, the United Kingdom) and the African Intellectual Property Organization (OAPI) (OAPI operates a PVP system covering its 17 Member States).
